The Company shall through its Executive Director conduct an introductory familiarization program when a new Independent Director comes on the Board of Company.

Such programs will provide an opportunity to the Independent Directors to interact with management personnel of the company and help them to understand the company's organizational structure, product, market, finance and such other areas as may arise from time to time.

Such program shall also familiarize the Independent Directors with their roles, right and responsibilities.

### 3. Disclosure of the Policy

This Policy shall be uploaded on the Company's website for public information and a web link for the same shall also be provided in the Annual Report of the Company.

### 4. Review of the Program

The Board will review this Program and make revisions as may be required from time to time.
